**SUBJECT: Appropriating the Statewide Projects for Multiple Program-Year Adjustments  
(\$232,322)**

The Administration requests approval of the attached resolution to appropriate Two Hundred Thirty-two Thousand Three Hundred Twenty-two Dollars (\$232,322) to the State Categorical Grants Fund (231) from the Alaska Department of Labor and Workforce Development for the multiple program-years statewide projects within the Planning Department. The grant will fund the program from July 1, 2002 through June 30, 2003.

This grant will provide funding for the Workforce Investment Act Adult and Youth program activities. This grant is a result of multiple program year adjustments made to correct the State's accounting records for the Adult and Youth programs. Operating under a consortium agreement between the Municipality of Anchorage and the Matanuska-Susitna Borough, training and employment opportunities are provided to qualified individuals through the combined service area.
