A RESOLUTION APPROPRIATING ONE HUNDRED AND EIGHTY THOUSAND DOLLARS (\$180,000) OF HOME INVESTMENT PARTNERSHIP (HOME) GRANT PROGRAM INCOME FROM THE RECOVERY OF UNITED STATES HOUSING AND URBAN DEVELOPMENT GRANT HOME INVESTMENT PARTNERSHIP PROGRAM (HOME) LOANS, AND APPROPRIATING SAID FUNDS TO THE FEDERAL CATEGORICAL GRANT FUND (241).

WHEREAS, the Municipality of Anchorage approved an Assembly Memorandum, AM 120-2001 (A), on March 20, 2001, outlining the use of one hundred and eighty thousand dollars (\$180,000) of HOME program income for the activities to be undertaken with the Home Investment Partnership (HOME) Program; and

WHEREAS, throughout the development of said application and 2000 Action Plan Amendment One, the Municipality of Anchorage actively sought participation of residents and representatives of lower income Anchorage neighborhoods, including community councils, and

WHEREAS, public testimony on said application and 2000 Action Plan Amendment One was heard before the Anchorage Assembly, and

WHEREAS, the Anchorage Municipal Assembly adopted the 2000 Action Plan Amendment One on March 20, 2001.

NOW, THEREFORE, the Anchorage Assembly Resolves:

<u>Section 1</u>. That the subject grants from the United States Department of Housing and Urban Development (HUD) for the PY2000 allocation of home program income funds, in the amount of one hundred and eighty thousand dollars (\$180,000), are hereby appropriated, to the Federal Categorical Grant Fund (241) for use in activities under the HOME program.

<u>Section 2.</u> That the allocation of said grant funds will be based on the activities outlined in the attached Assembly Memorandum, and in the 2000 Action Plan Amendment One, which incorporates Anchorage's Continuum of Care. Accounting information is outlined in the attached Assembly Memorandum.

Section 3. That this resolution shall be effective immediately upon passage and approval by the Anchorage Assembly.

8 Community Development Division, Planning Department, requests approval of the attached
9 resolution to appropriate One Hundred and Eighty Thousand dollars (\$180,000) of Housing and
10 Urban Development (HUD) HOME Investment Partnership Grant (HOME) program income funds
11 to the AnCHOR program. AnCHOR is a down payment assistance program for low and moderate12 income residents; also, program income is derived from repayment of housing and rehabilitation
13 loans which need to be reprogrammed annually according to HUD guidelines.

Assembly Memorandum 120-2001 (A), signed on March 20, 2001 by the Anchorage Assembly, approved the allocation of \$180,000 in program income to AnCHOR, with priority given to displaced residents from Plaza 36 and the Alaska Village mobile home parks. The Assembly asked for these funds to expedite implementation of services for families facing dislocation when their trailer parks were sold.
