  dentists, dental assistants, pharmacists, veterinarians, social workers, health care administrators and
  clergy, among others; and
- Develop a program to match and utilize the services of trained medical volunteers with the community's ongoing public health needs, such as immunizations, health and nutrition education, and blood drives.
