A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY APPROPRIATING
THREE HUNDRED NINETY THREE THOUSAND SIX HUNDRED EIGHTY SIX
DOLLARS (\$393,686) FROM THE U.S. DEPARTMENT OF JUSTICE, OFFICE OF
JUSTICE PROGRAMS, LOCAL LAW ENFORCEMENT BLOCK GRANT AND FORTY
THREE THOUSAND SEVEN HUNDRED FORTY THREE DOLLARS (\$43,743) AS A
CONTRIBUTION FROM THE ANCHORAGE POLICE SERVICE AREA FUND (151),
ANCHORAGE POLICE DEPARTMENT 2002 OPERATING BUDGET, TO THE
FEDERAL CATEGORICAL GRANTS FUND (241), ANCHORAGE POLICE
DEPARTMENT, FOR THE PURPOSE OF UNDERWRITING PROJECTS TO REDUCE
CRIME AND IMPROVE PUBLIC SAFETY.


THE ANCHORAGE MUNICIPAL ASSEMBLY RESOLVES

Section 1. That the sum of THREE HUNDRED NINETY THREE THOUSAND
SIX HUNDRED EIGHTY SIX DOLLARS (\$393,686), is appropriated from the U.S. Department
of Justice, Office of Justice Programs, Local Law Enforcement Block Grant (LLEBG) Program
to the Federal Categorical Grants Fund (241), Anchorage Police Department for the purpose of
underwriting projects to reduce crime and improve public safety.


Section 2. That the sum of FORTY THREE THOUSAND SEVEN HUNDRED
FORTY THREE DOLLARS (\$43,743) is appropriated as a match from the Anchorage
Metropolitan Police Service Area Fund (151) to the Federal Categorical Grant Fund (241) for
the purpose of underwriting projects to reduce crime and improve public safety.

Section 3. This resolution shall take effect immediately upon passage and
approval.

Subject: Appropriation from the U.S. Department of Justice, Office of Justice Programs for a Local Law Enforcement Block Grant (LLEBG) Award 2002-LB-BX-0380. \$437,429

Local Law Enforcement Block Grants, authorized by the Omnibus Consolidated and Emergency Supplemental Appropriations Act, 1999 Public Law 105-277, provide local governments with funds to underwrite projects to reduce crime and improve public safety. The Municipality of Anchorage has been awarded a grant in the amount of \$393,686 with a required local match of \$43,743 for a total program budget of \$437,429. These amounts are requested to be appropriated to the Federal Categorical Grants Fund (241) for use by the Anchorage Police Department. The term of this grant is 24 months from the date drawn by the Municipality (October 8, 2002).

The Grant Advisory Board met on October 7, 2002 and recommended the use of funding as follows:

\$240,000	Sexual Assault Response Team (SART) Contract (1 year)
<u>197,429</u>	Additional Funding for Enhanced 911 Project
\$437,429	

As required, a public hearing notice was advertised in a local newspaper and the hearing was held on October 7, 2002 at APD Headquarters. The hearing provided the community an opportunity to comment on the proposed use of the block grant. No public comments were expressed at the hearing.
