1 AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS OF THE MUNICIPALITY AT  
2 THE APRIL, 2003 REGULAR MUNICIPAL ELECTION A BALLOT PROPOSITION TO  
3 AMEND THE ANCHORAGE MUNICIPAL CHARTER BY ADDING TO THE CHARTER'S  
4 BILL OF RIGHTS A NEW SECTION ESTABLISHING THE CITIZENS' RIGHT TO  
5 OBJECTIVE PERFORMANCE MEASURES IN THE DELIVERY OF MUNICIPAL SERVICES.

8 THE ANCHORAGE ASSEMBLY ORDAINS:

10 **Section 1.** A proposition in substantially the following form and substance shall be submitted to  
11 the qualified voters of the Municipality at the regular Municipal election April 1, 2003:

15 **RIGHT TO OBJECTIVE MEASURES OF PERFORMANCE**  
16 **IN THE DELIVERY OF MUNICIPAL SERVICES**

18 Shall Article II of the Municipality of Anchorage Charter be amended to add the  
19 following section 16. to the Charter's Article II, Bill of Rights?

*(New language is underlined.)*

22 This Charter guarantees rights to the people of Anchorage that are in  
23 addition to rights guaranteed by the Constitution of the United States of  
24 America and the Constitution of the State of Alaska. Among rights  
25 guaranteed by this Charter are:

27 (16) The right to objective measures of performance in the delivery of  
28 Municipal services.  
29

30 **Section 2.** Sections 1. and 2. of this ordinance shall become effective immediately upon its  
31 passage and approval by the Assembly. The proposition contained in Section 1. of this ordinance  
32 shall become effective upon certification of the April 1, 2003 general election, if and only if, the  
33 proposition contained in Section 1. is approved by a majority of the qualified voters of the  
34 Municipality voting on the question.
