A BALLOT PROPOSITION TO CREATE A NEW STREET LIGHT SERVICE 3 AREA DESIGNATED AS THE GLENN VIEW WEST SUBDIVISION STREET LIGHT 4 SERVICE AREA, AND, UPON VOTER APPROVAL, AMENDING MUNICIPAL CODE SECTION 27.30.700 TO CONSOLIDATE THE GLENN VIEW WEST SUBDIVISION 6 STREET LIGHT SERVICE AREA WITH THE EXISTING EAGLE RIVER STREET LIGHT 7 SERVICE AREA. 8 9 10 WHEREAS, a petition has been received showing public interest to create a new Street Light 11 Service Area designated the Glenn View West Subdivision Street Light Service Area (SLSA), 12 consisting of Block 1, Lots 1-11 and Block 2, Lots 1-26 to operate and maintain street lights within 13 the Glenn View West Street Light Service Area; and 14 15 WHEREAS, it is in the public interest to provide for operation and maintenance of street lights in 16 the area known as the Glenn View West Subdivision SLSA; and 17 18 WHEREAS, the additional street lights and anticipated tax revenue increase will not have a 19 significant impact on the Eagle River Street Light Service Area (SLSA); and 20 21 WHEREAS, the Eagle River SLSA consists of sixteen non-contiguous areas in Eagle River, 22 making balloting an extreme hardship for the Municipal Clerk; and 23 24 WHEREAS, the creation of a new service area approved only by the qualified voters residing in 25 the Glenn View West Subdivision Block 1, Lots 1-11 and Block 2, Lots 1-26, followed by an 26 automatic consolidation with the Eagle River SLSA by the Assembly, provides a manageable and 27 fair mechanism to accomplish incorporating the new service area into the Eagle River SLSA with 28 no apparent adverse effect on the Eagle River SLSA; and 29 30 WHEREAS, the services to be received in the Glenn View West Subdivision SLSA are the same 31 32 level of such services provided in the Eagle River SLSA; and 33 WHEREAS, there has been a showing of interest of residents in the Glenn View West Subdivision 34 area to join the Eagle River Street Light Service Area in order to properly operate and maintain the 35 existing street lights in their area; and 36 37 WHEREAS, it is in the public interest to provide for operating and maintaining the street lights in 38 the Glenn View West Subdivision area; now therefore, 39

Section 1. Pursuant to Anchorage Municipal Charter 9.01(a), a ballot proposition containing the
following language shall be submitted to the qualified voters of the Municipality residing in the
Glenn View West Subdivision Block 1, Lots 1-11 and Block 2, Lots 1-26 at the regular Municipal
election on April 1, 2003:

Proposition 9 APPROVING CREATION OF A NEW SERVICE AREA TO OPERATE AND 10 MAINTAIN STREET LIGHTS IN THE GLENN VIEW WEST SUBDIVISION 11 BLOCK 1, LOTS 1-11 AND BLOCK 2, LOTS 1-26. 12 13 Shall a new street light service area be created retroactively as of January 1, 2003, 14 designated as the Glenn View West Street Light Service Area Block 1, Lots 1-11 15 and Block 2. Lots 1-26, to operate and maintain street lights within the Glenn View 16 West Subdivision? 17 18 If the creation of this new service area is approved, the new street light service 19 area will be automatically consolidated with the existing Eagle River SLSA. The 20 existing mill rate in the Eagle River SLSA is 0.5 mills. 14 The attached Ordinance creates a new Street Light Service Area retroactively as of January 1, 15 2003, designated the Glenn View West Subdivision Street Light Service Area, namely Block 1, 16 Lots 1-11 and Block 2, Lots 1-26, which are not presently within the Eagle River Street Light 17 Service Area, to operate and maintain street lights within the Glenn View West Subdivision area 18 and amends Anchorage Municipal Code Section 27.30.700 to automatically consolidate the Glenn 19 View West Subdivision Street Light Service Area with the Eagle River Street Light Service Area.

A petition from the Glenn View West Subdivision owners has been received requesting approval of street light service of the street lights located within the Glenn View West Subdivision. The public improvements constructed in the Glenn View West Subdivision were inspected and found to meet Municipal standards and were accepted for operation and maintenance. There are residents currently living within the proposed service area.

Inclusion of the proposed street light service area for the Glenn View West Subdivision to the
existing Eagle River Street Light Service Area should not have a significant fiscal or operational
impact to the Eagle River Street Light Service Area. In addition, this street light system should not
present any hardship for the Street Maintenance Division. If approved, this ordinance will become
effective beginning with the BY 2003 tax year (January 1, 2003).

The Eagle River Street Light Service Area does not have a formal board of supervisors who oversee the service area, and all operation and maintenance are administered by Street Maintenance through private contractors. In addition, automatic consolidation is a feasible and rational method to efficiently provide for the operation and maintenance services of the existing street lights. The services to be received in the Glenn View West Subdivision Street Light Service Area are the same level of such services provided in the Eagle River Street Light Service Area.

The consolidation of the street light service area is in conformance with the legislative policy to minimize the number of new service areas, especially when it is feasible and practical to consolidate accordingly.


