AN ORDINANCE AMENDING CHAPTER 15.80 OF THE ANCHORAGE MUNICIPAL CODE TO
AUTHORIZE DEPARTMENT OF MOTOR VEHICLE REGISTRATION RENEWAL SERVICES
AT THE ENVIRONMENTAL SERVICES COUNTER, DEPARTMENT OF HEALTH AND
HUMAN SERVICES AND ASSESSMENT OF A FEE FOR THE SERVICE.

Section 1. That the Anchorage Municipal Code section 15.80.010 *General Provisions* is hereby
amended by adding a new subsection to read as follows:

15.80.010 **General Provisions.**


K. Registration renewal. DMV registration renewals may be accepted and processed through
the department of health and human services, environmental services counter. In addition
to other applicable fees, a \$10.00 transaction processing fee shall be charged for DMV
vehicle owner registration renewals made at the department of health and human services,
environmental services division.

Section 2. This ordinance shall be effective immediately upon its passage and approval by the
Assembly.

Subject: Assembly Ordinance No. AO 2003-44 amending Chapter 15.80 of the Anchorage Municipal Code to collect transaction fees to provide Department of Motor Vehicle registration renewal services at the public counter, Environmental Services Division, Department of Health and Human Services.

The Municipality is entering into a Registration Renewal Participation Agreement with the State of Alaska Division of Motor Vehicles to allow vehicle registration renewals to walk-in customers at the public counter of the Environmental Services Division, DHHS. Offering this DMV service will greatly enhance our customer service counter function related to the Vehicle Inspection and Maintenance Program (IM) by eliminating the need for DMV registration renewal customers to go to DMV, come to the 825 "L" Street location for IM services, go through the process there and return to DMV to finish re-registration. This is inefficient and has resulted in numerous frustrated customers and many complaints.

The ordinance authorizes the Municipality to collect the standard ten dollar (\$10.00) transaction fee charged by others offering DMV registration renewals. There is no additional financial impact to the public. This program was discussed during an Assembly budget work session and funding was approved in the FY 2003 budget contingent upon enactment of this ordinance. These transaction fees will contribute funding necessary to offer these services.

THE ADMINISTRATION RECOMMENDS THE ASSEMBLY APPROVE AMENDING CHAPTER 15.80 OF THE ANCHORAGE MUNICIPAL CODE AND AUTHORIZE THE COLLECTION OF STATE DMV REGISTRATION RENEWAL FEES BY THE MUNICIPALITY.
