REGISTRATION OF KEGS OR OTHER CONTAINERS**

The purpose of this ordinance is to correct references to Alaska Statute in AO 2003-8 and to change the effective date of the requirement to begin registration of kegs or other containers holding four or more gallons of alcoholic beverage and held for sale or lease.

All references to AS 04.16, Licensing, will be changed to correctly reference AS 04.11, Licensing.

The effective date will be postponed from April 1, 2003 to August 1, 2003 to allow necessary time for successful and effective implementation.

Approval of AO 2003-48 is recommended.
