Ordinance amending Anchorage Municipal Code Section 3.70.060 to change

the definition of exempt employees as related to the staff of the Treasurer

The attached ordinance amends Anchorage Municipal Code Section 3.70.060C.7. to change the definition of exempt employees as related to the staff of the Treasurer. Specifically, staff falling under the Treasurer which are to be deemed exempt from a collective bargaining unit will now be restricted to those business units of the Treasurer's Division charged with property taxes billing (Org. 1346 – Taxes Billing) and Administration (Org. 1341).

All other staff of the Treasurer, except supervisory personnel, not specifically referenced within the revised definition contained in AMC 3.70.060C.7. are no longer restricted from belonging to a collective bargaining unit.

### **Background**

The Finance Department has completed a major departmental reorganization begun in November 2000. Included in the Finance Department's reorganization plan is a formal transfer of the Personal and Business Property Taxes work group from the Property Appraisal Division to the Treasury Division and the consolidation of customer service functions of both Property Appraisal and Treasury to the third floor of City Hall.

The attached ordinance change is one of the final steps necessary to completing implementation of the Finance Department's reorganization plan.

Under the current language of AMC 3.70.060C.7. all staff of the Treasurer "shall be deemed exempt employees". The current Municipal Code precludes the Personal and Business Property Taxes work group from becoming the staff of the Treasurer. The attached ordinance is intended to fix this conflict and allow the Personal and Business Property Tax work group to formally become the staff of the Treasurer without losing their collective bargaining status.

Bringing the Personal and Business Property Taxes work group under the responsibility of the Treasurer recognizes the many common characteristics that exist between that work group and the Treasury Division's Program Taxes work group (i.e., hotel, tobacco, rental vehicle) i.e., both work groups receive and process self-reported filings from businesses operating within the Municipality of Anchorage. In addition, both work groups share a common focus on auditing those businesses required to file and their work is driven by the need to ensure accuracy, completeness, fairness and compliance in administering the local tax laws applicable to businesses.

Subsequent to the passage of this ordinance, cross training of staff will commence and the work groups will be joined. Finance believes this effort, combined with technology improvements underway for the Personal and Business Property Tax system, will substantially increase the effectiveness of both work groups.
