AN ORDINANCE SETTING THE RATE OF TAX LEVY AND LEVYING TAXES FOR THE  
MUNICIPALITY OF ANCHORAGE AREAWIDE GENERAL PURPOSES INCLUDING  
MUNICIPAL SCHOOLS AND ALL SERVICE AREAS OF THE MUNICIPALITY FOR THE  
MUNICIPAL TAX YEAR 2003 AND APPROVING THE TOTAL AMOUNT OF MUNICIPAL TAX  
FOR FISCAL YEAR 2003

THE ANCHORAGE ASSEMBLY ORDAINS

**Section 1.** That the Municipal Assembly hereby fixes the rate of tax levy for the Municipality the tax year 2003 for Areawide General Purposes, including Areawide Schools, and all service areas of the Municipality. The Municipal Assembly levies this tax upon the full value of assessed taxable real and personal property, as follows.

**Section 36.** Anchorage Building Safety Service Area a tax of 0.01 mills

**Section 37.** That the property tax amount approved for 2003 (the “amount approved by the Assembly for the preceding year” to be used in the determination of the 2004 tax limitation), including real property, personal property, and Municipal utilities services assessment (MUSA) as defined by Anchorage Municipal Charter §14.03 and AMC 12.25.040A. are as follows:

General Government	<b>\$ 171,316,195</b>
Anchorage School District	<b><u>\$ 143,969,120</u></b>
Total	<b>\$ 309,071,170</b>

**Section 38:** That upon final passage and approval of a resolution of the Municipality of Anchorage revising the 2003 General Government Operating Budget, the Director of the Office of Management and Budget is authorized and directed with the concurrence of the Municipal Attorney, as the Reviser of ordinances, to make those technical amendments in computation of individual mill levies set forth in Section 2 – 36 above to reflect those budget revisions.

**Section 38.** That this ordinance shall become effective upon passage and approval by the Anchorage Municipal Assembly.
