AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY CONTINUING OR REESTABLISHING THE ANCHORAGE MEMORIAL PARK CEMETERY ADVISORY BOARD PURSUANT TO ANCHORAGE MUNICIPAL CODE SECTION 4.05.150.

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. Pursuant to Anchorage Municipal Code Section 4.05.150, the Anchorage Memorial Park Cemetery Advisory Board shall be and is hereby continued or reestablished for an additional period of three (3) years from and after April 2, 2003. During the period of time from and after April 2, 2003 until the effective date of this ordinance, all actions of the Anchorage Memorial Park Cemetery Advisory Board, all appointments thereto and all unexpired terms of its members shall continue to be and constitute the actions of, appointments to and the unexpired terms of its members, as the case may be, as if it had not been terminated by operation of law.

Section 2. Nothing in this ordinance shall be taken as or constitute any approval, ratification, implementation of, or ruling or action by the Anchorage Municipal Assembly on any action of the Anchorage Memorial Park Cemetery Advisory Board.

Section 3. This ordinance shall take effect immediately upon passage and approval by the Assembly.
