AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY AMENDING ANCHORAGE MUNICIPAL CODE TITLE 17 BY ADDING A NEW SECTION 17.10.090 TO ALLOW FOR OFF-LEASH DOG PARK SPACES

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1: That the Anchorage Municipal Code Title 17 is amended by adding a new section 17.10.090 to read as follows:

<u>17.10.090</u> Off-leash dog park spaces.

A. Not withstanding any other provision of this Code, legally licensed dogs shall be allowed, unleashed, in the area described below:

University Lake - (Legal Description here)

B. Rules and regulations for the use of off-leash dog park spaces:

- 1. Dogs must be leashed upon entering and leaving the dog park space.
- 2. Aggressive dogs, dogs declared dangerous, dogs classified as Level one, two, three, four, or five, and female dogs in heat are prohibited.
 - 3. Dogs must have and bear a current dog license and rabies vaccination tag.
 - 4. The dog owner or custodian must remain in the dog park space with the dog.
 - 5. Dogs must be under voice, whistle, or hand-signal control.
 - 6. Dog feces must be cleaned up by the dog owner or custodian.
 - 7. Holes dug by dogs must be filled by the dog owner or custodian.

Section 2: That the Director of the Cultural and Recreational Services Department may designate other off-leash dog park spaces within the Municipality of Anchorage subject to approval by the Assembly.

Section 3: That this ordinance shall take effect immediately upon passage and approval.
