10 Section 1. Anchorage Municipal Code is hereby amended by enactment of a new subsection  
11 2.40.030E., Districts Recognized; Special Provision, to read as follows:

13 E. *Districts Recognized; Special Provision.* The Municipality recognizes the Girdwood  
14 Board of Supervisors as the community council, ex-officio, which serves the  
15 Girdwood Community Association/Land Use Committee boundary area depicted on  
16 Map 10 located in section 2.40.090 [AREA DEPICTED ON MAP 10  
17 (TURNAGAIN ARM COMMUNITY COUNCIL DISTRICTS) AS THE  
18 BOUNDARY FOR THE GIRDWOOD COMMUNITY ASSOCIATION,  
19 PREPARED BY THE DEPARTMENT OF PLANNING DATED JUNE 17, 2003,  
20 AND ADOPTED BY THE ASSEMBLY ON JULY 8, 2003].

22 Section 2. This ordinance shall become effective immediately upon its passage and approval.

17 the Department of Planning dated June 17, 2003, and adopted by the Assembly on  
18 July 8, 2003.
