

**Subject: TO CHANGE THE EFFECTIVE DATE OF AO 2003-8 REGARDING
REGISTRATION OF KEGS OR OTHER CONTAINERS**

The purpose of this ordinance is to change the effective date of the requirement to begin registration of kegs or other containers holding alcoholic beverage and held for sale or lease.

The effective date will be postponed from August 1, 2003 to October 1, 2003. The postponement will allow the necessary time for revision of the new Municipal Code Section 10.50.050, Keg or Container Registration, to reflect suggestions made during the July 11, 2003 worksession. Revising the ordinance prior to the effective date will ensure successful and effective implementation.

Approval of this ordinance is recommended.
