SENIOR VOLUNTEER PROGRAMS


THE ANCHORAGE ASSEMBLY RESOLVES:

Areawide General Fund (101) Balance to the Public Transportation Department.


Section 2: That this appropriation is to be used to provide AnchorRIDES for seniors
