The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities for a DUI .08 Impaired Driving Enforcement Blitz program. This grant will be used to support enforcement during the periods December 20, 2002 thru January 5, 2003 and various blitz periods thru January 31, 2004.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of Impaired Driving violations within the Municipality of Anchorage. Through increased awareness and enforcement of Impaired Driving offenses, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.
