A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING SUPPLEMENTAL AWARD OF THREE HUNDRED EIGHTY FIVE THOUSAND ONE HUNDRED FORTY SIX DOLLARS (\$385,146) TO THE STATE CATEGORICAL GRANTS FUND (231) FROM THE ALASKA DEPARTMENT OF LABOR AND WORKFORCE DEVELOPMENT FOR THE PY 2002 WORKFORCE INVESTMENT ACT TITLE 1B DISLOCATED WORKER PROGRAM WITHIN THE PLANNING DEPARTMENT.

THE ANCHORAGE ASSEMBLY RESOLVES


Section 1. That the sum of Three Hundred Eighty Five Thousand One Hundred Forty Six Dollars (\$385,146) be appropriated to the State Categorical Grants Fund (231) from the Alaska Department of Labor and Workforce Development for the PY 2002 Workforce Investment Act Title 1B Dislocated Worker Program within the Planning Department.

**SUBJECT: Supplemental Appropriation to the Workforce Investment Act Title 1B Dislocated  
Worker Program for Program Year 2002 (\$385,146)**

The Administration requests approval of the attached resolution to appropriate the supplemental funding of Three Hundred Eighty Five Thousand One Hundred Forty Six Dollars (\$385,146) to the State Categorical Grants Fund (231) from the Alaska Department of Labor and Workforce Development for the PY 2002 Workforce Investment Act Title 1B Dislocated Worker Program within the Planning Department. The grant will fund the program from July 1, 2002 through June 30, 2003.

These funds will be used to provide core, intensive and training services within the One-Stop system to individuals who meet the dislocated worker criteria. Operating under a consortium agreement between the Municipality of Anchorage and the Matanuska-Susitna Borough, training and employment opportunities are provided to qualified individuals through the combined service area.
