WHEREAS, the Home Rule Charter of the Municipality of Anchorage guarantees the citizens the right to assistance of a municipal ombudsman whose jurisdiction, power, and duties include acts and omissions of employees and agents of the School District, as well as employees and agents of the Municipality; and

WHEREAS, the Charter further provides the Office of the Ombudsman be established in the Legislative branch of government with functions and responsibilities as outlined in Section 2.60 of the Anchorage Municipal Code; and

WHEREAS, AMC Section 2.60 further provides that the term of office for the Ombudsman shall be two years, ending on December 31 of even-numbered years and that the Assembly sets an annual salary.

NOW, THEREFORE, the Anchorage Assembly resolves that Greg Moyer is appointed Municipal Ombudsman for a two-year term ending on December 31, 2004 and that he will receive an annual salary of \$70,000.
