In November, the Auditors advised the Municipality that an additional contract amendment was necessary to complete the Payroll and Internal Control and Process review, conduct an organizational study of the HR Department with a focus on payroll, and provide assistance in the development of an implementation plan. The additional funding necessary to complete this project is not to exceed \$55,000. The expenditure and revenue information follows:
