A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE ACCEPTING WHEN TENDERED THE SUM OF ONE HUNDRED TWENTY THOUSAND DOLLARS (\$120,000) FROM THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION & PUBLIC FACILITIES; AND APPROPRIATING SAID GRANT, AND SIXTEEN THOUSAND FIVE HUNDRED TEN DOLLARS (\$16,510) AS A CONTRIBUTION FROM THE 2003 ANCHORAGE POLICE OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151), TO THE STATE CATEGORICAL GRANTS FUND (231) ANCHORAGE POLICE DEPARTMENT, FOR THE YOUTH AT RISK DRIVING ENFORCEMENT PROGRAM.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum, not to exceed, ONE HUNDRED TWENTY THOUSAND DOLLARS (\$120,000), is accepted when tendered from the State of Alaska, Department of Transportation & Public Facilities, and appropriating said grant to the State Categorical Grants Fund (231), Anchorage Police Department, for Youth at Risk Driving Enforcement Program.

Section 2. That the sum, not to exceed, SIXTEEN THOUSAND FIVE HUNDRED TEN DOLLARS (\$16,510), is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2003 Anchorage Police Department Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

**From:** Mayor

**Subject:** State of Alaska, Department of Transportation & Public Facilities, has allocated Federal Funds for a Youth at Risk Driving Enforcement Grant and local match required. (\$136,510)

The Municipality of Anchorage anticipates receiving a grant from the State of Alaska, Department of Transportation & Public Facilities for a Youth at Risk Driving Enforcement Program. This grant will be used to support enforcement of seat belt usage and to reduce speeding among youth drivers in the vicinity of local schools and neighborhoods.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of Youth at Risk Driving violations within the Municipality of Anchorage. Through increased awareness and enforcement of Youth at Risk Driving offenses, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.

The notice to proceed authorizes \$50,000 from the grantor. The total amount of grant award will be increased up to \$120,000 upon Federal Budget approval. A special condition of this grant is that the department provide matching funds. The total projected Municipal cost is \$16,510, which has been budgeted in the 2003 Operating Budget. This grant began December 01, 2002 and will end on September 30, 2003.
