A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RECOGNIZING MARCH 2-8, 2003 AS BLACK CHURCH WEEK OF PRAYER FOR THE HEALING OF AIDS

WHEREAS, of the estimated 40,000 cases of new HIV infections each year, more than 50% occur amongst African Americans; and

WHEREAS, AIDS is the number one cause of death for Black adults aged 25 to 44, before heart disease, cancer, and homicide; and

WHEREAS, Black children represent almost two-thirds (62%) of all pediatric reported cases; and

WHEREAS, as Black Church Week of Prayer is modeled after the innovative Harlem Week of Prayer for the healing of AIDS, established in 1989; and

WHEREAS, the purpose of the Black Church Week of Prayer for the Healing of AIDS is to bring National attention to the role Black Churches are playing in the AIDS crisis; and

WHEREAS, Black Church Week of Prayer is the largest AIDS awareness program targeting African American communities with 77 AIDS service organizations and health departments across the United States; and

WHEREAS, churches are encouraged to build ministries that speak to the suffering of people due to HIV/AIDS; and

WHEREAS, local Anchorage congregations such as Shiloh Missionary Baptist, First Christian Methodist Episcopal, and St. Paul Methodist Episcopal Churches are participating in the Balm of Gilead Black Church Week of Prayer for the Healing of AIDS.

NOW, THEREFORE, the Anchorage Assembly resolves that Anchorage join the rest of the Nation in recognizing March 2-8, 2003 as

BLACK CHURCH WEEK OF PRAYER FOR THE HEALING OF AIDS

and encourages spiritual renewal, transformation, and HIV prevention education.
