Appropriation is now being sought for (\$4,000) in additional funds and a Municipal contribution of (\$110) for Intragovernmental charges which are currently budgeted in the 2003 Library operating budget, budget unit 5382, within the Areawide General Fund (101). These grant funds and contributed match cover the grant period of December 13, 2002 through August 15, 2003.

The Public Access to Computers and the Internet Program seeks to expand public access to computers and the Internet. These additional funds will be used to provide upgraded internet access to the Mountain View Branch Library and other items in support of public access computing in the library.
