A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY PROCLAIMING APRIL 2003 SEXUAL
ASSAULT AWARENESS MONTH AND ENCOURAGING THE CITIZENS OF ANCHORAGE TO WORK
TOGETHER TO ELIMINATE THIS CRIME IN OUR COMMUNITY

WHEREAS, in the United States a woman is raped every 45 seconds, one in five adult women will
be raped at some point in her life, and the rape rate in Alaska is more than twice the National average; and

WHEREAS, in the United States one in four female and one in six male children will be sexually
assaulted before they are 18 years old, and Alaska has six times the National average of reported child
sexual assault; and

WHEREAS, sexual assault affects every person within the Municipality of Anchorage whether as a
victim survivor or as a family member, significant other, neighbor or co-worker of a victim survivor; and

WHEREAS, many citizens are working to provide quality services and assistance to sexual assault
survivors through programs including education, crisis hotlines, support, comfort, and advocacy services
throughout all stages of the recovery process; and


WHEREAS, due to the prevalence of these crimes we must work together as a community to increase
public awareness and to educate our population about sexual assault prevention measures.

NOW, THEREFORE, the Anchorage Municipal Assembly proclaims April 2003


Sexual Assault Awareness Month

and encourages the citizens of Anchorage to work together to eliminate this crime in our community.


