A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THE SUM OF TWENTY THOUSAND DOLLARS (\$20,000) FROM THE STATE OF ALASKA, ALCOHOLIC BEVERAGE CONTROL BOARD AND FOUR HUNDRED DOLLARS (\$400) AS A CONTRIBUTION FROM THE 2003 ANCHORAGE POLICE DEPARTMENT OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE STATE CATEGORICAL GRANTS FUND (231), ANCHORAGE POLICE DEPARTMENT, FOR THE ALCOHOL SALES TO MINORS ENFORCEMENT PROGRAM.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of TWENTY THOUSAND DOLLARS (\$20,000) is appropriated from the State of Alaska, Alcoholic Beverage Control Board to the State Categorical Grants Fund (231), Anchorage Police Department, for the Alcohol Sales to Minors Enforcement Program.

Section 2. That the sum of FOUR HUNDRED DOLLARS (\$400) is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2003 Anchorage Police Department Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.
