A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING SIXTY ONE THOUSAND TWO HUNDRED TWELVE DOLLARS (\$61,212) IN PREVIOUSLY UNAPPROPRIATED MILLER'S REACH FIRE INSURANCE RECOVERY REVENUES TO THE ANCHORAGE FIRE SERVICE AREA CAPITAL IMPROVEMENT (431) FUND FOR THE PURCHASE OF FIRE AND RESCUE EQUIPMENT.

THE ANCHORAGE ASSEMBLY RESOLVES:

**Section 1:** That the sum of Sixty One Thousand Two Hundred Twelve Dollars (\$61,212) in previously unappropriated Miller's Reach Fire Insurance Recovery Revenues are hereby appropriated to the Anchorage Fire Service Area Capital Improvement (431) Fund for the purchase of fire and rescue equipment.

The insurance proceeds in question were identified in December, 2001 and transferred to the Miller's Reach capital improvement account following the completion of an analysis of unassigned revenues.
