**SUBJECT: Appropriating the Workforce Investment Act Program Year (PY) 2002/Federal
Fiscal Year (FFY) 2003 Statewide Projects - Adult Grant**

The Administration requests approval of the attached resolution to appropriate Two Hundred Twenty Thousand Dollars (\$220,000) to the State Categorical Grants Fund (231) from the Alaska Department of Labor and Workforce Development for the PY 2002/FFY 2003 WIA Statewide Projects - Adult Grant within the Planning Department. The grant will fund the program from April 1, 2003 through June 30, 2003.

These funds will be used to provide additional funding for the Title I Adult Program. The overall purpose of the Adult program is to create and maintain a seamless continuum of educational and career development opportunities and incentives that assist eligible adults in selecting, pursuing, and obtaining careers that result in self sufficiency. Operating under a consortium agreement between the Municipality of Anchorage and the Matanuska-Susitna Borough, training and employment opportunities are provided to qualified individuals through the combined service area.
