3 SUBJECT: A Resolution of the Municipality of Anchorage Appropriating Ninety-Nine Thousand Dollars (\$99,000) from the Areawide General Fund (101) Balance to 4 5 the Miscellaneous Capital/Pass-Thru Capital Improvement Program Fund (409) 6 to Pay for Alaska Superior Court Approval of the Rabbit Creek View Subdivision 7 and Rabbit Creek Heights Subdivision Re-Survey and Monumentation of the New 8 Platted Lots.

Additional funding is needed for the Rabbit Creek View Subdivision and Rabbit Creek Heights 10 Subdivision Survey Improvement Assessment District to finish the survey and replat project. 11 The attached resolution appropriates \$99,000 from the Areawide General Fund (101) Balance to 12 13 the Miscellaneous Capital/Pass-Thru Program Fund to pay for remaining subdivision 14 monumentation, plat preparation and legal fees to obtain plat approval. 15

16 Original project funding and two additional appropriations paid for the initial re-surveying of the 17 subdivisions, filing an action in Alaska Superior Court to determine the location of boundary lines, and resolving boundary issues with individual property owners and easement interests 18 19 with affected utility companies. Resolution of the easement interests and the location of their boundaries have proven to be very complicated and legally time consuming. The effort 20 21 expended to complete this process has exhausted all the funding budgeted for trial preparation 22 and testimony in court as well as a portion of the subdivision monumentation budget. No funding 23 is available for final plat preparation and filing. The monumentation of both subdivisions is 24 approximately 75% complete and plat preparation is 85% complete, depending on orders the 25 Court may issue as part of the plat approval. Funding the \$99,000 appropriation will help the 26 project reach completion. 27
