Repairs to Various Municipal Facilities Damaged by the Windstorm of March 12, 2003.

The windstorm of March 12, 2003, caused damage to several Municipal facilities. Prompt action to repair torn roofs, broken pipes and loose siding is ongoing to prevent further damage to Municipal facilities and ensure they are safe for public use. Current damage estimates already exceed the amount approved in the Areawide Service Area (Fund 101) 2003 General Operating Budget for routine contracted facility repairs.

An insurance claim is pending but actual damage costs will not be known until contracts can be awarded for all of the various facility repairs. This \$100,000 appropriation is equal to the \$100,000 insurance deductible amount The \$100,000 will provide immediate funding to the Areawide Service Area (Fund 101) 2003 General Operating Budget for contractual repairs to the damaged facilities and prevent disruption of continuing routine repair and maintenance of municipal facilities.
