same time, reducing further trauma to victims; and

finest in the nation; and

WHEREAS, her expertise in evidence collection and courtroom testimony has greatly improved the
ability of the Anchorage Police Department to prosecute sexual assault suspects; and

WHEREAS, Tara Henry is a leader in her field in postmortem forensics in sexual assaults and as
an instructor for Sexual Assault Nurse Examiner training, she ensures that her expertise is passed on to
her students; and

WHEREAS, for the past three years, she has been the driving force behind annual training in
interpersonal violence and the yearly seminar she oversees is attended by some of the leading National
experts in sexual violence.

NOW, THEREFORE, the Anchorage Municipal Assembly recognizes and commends

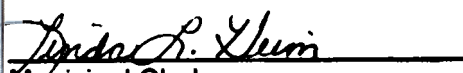
