Originally legal access to those 18 properties fronting this street was to be from Old Seward Highway and addresses were assigned 19 as such. However, the homes were built fronting the alley, with the alley actually serving as 20 primary access. The Fire and Police Departments are concerned with being able to locate these 21 homes along this alley way. Affected property owners were initially notified of the pending action 22 to name the street "Marl Way". This was disapproved by a significant portion of property owners. 23 Second notices were sent proposing the name "Aleut Way". Two responses were received both 24 disapproving the name, however since this did not represent a significant portion of property 25 owners the executive order was issued May 8, 2003. 26 27 Following the issuance of the executive order, affected property owners were again notified. 
