17 THE ANCHORAGE ASSEMBLY RESOLVES:

19 WHEREAS, the property west of Crowberry Loop is being developed and Crowberry  
20 Loop will be extended as a cul-de-sac; and

22 WHEREAS, according to Anchorage Municipal Code of Regulations, a cul-de-sac  
23 shall be designated a "circle"; and

25 WHEREAS, there is already a Crow Berry Circle in the Municipality of Anchorage  
26 and having two roads with similar names would cause confusion with 911  
27 emergency dispatching and the US Postal Service;

29 NOW THEREFORE, the Anchorage Municipal Assembly resolves: that Executive  
30 Order 2003-004 issued by the Mayor on May 8, 2003, be ratified and Crowberry  
31 Loop be renamed Hollyberry Circle.

**Proposed Petition: To Keep Name Crowberry Loop**

**As a resident and/or owner of a home in Raspberry Subdivision, currently named Crowberry Loop, I would like to ask you to forfeit any name changes for this street.**

**This street was zoned or planned to be a loop when the name was accepted in the beginning. For reasons unknown to us, these plans did not follow through. When we purchased our home none of the development plans were included in our closing paperwork about the future plans of Crowberry Loop. Therefore my husband and I were unable to dispute the current plans to make it a cul-de-sac instead of a loop as originally planned for.**
