Subject: AR 2003-<u>172</u> Appropriating \$80,000 from the State of Alaska for Coastal Impact Assistance Program Grant for FY2003

For the past 23 years, with the endorsement of the Municipal Assembly, the Municipality of 6 Anchorage (MOA) has been implementing the Anchorage Coastal Management Program. During 7 this period, the State of Alaska has provided pass-through grants from the Federal National 8 Oceanic and Atmospheric Administration (NOAA). This year NOAA is funding MOA staff 9 support to update and convert original coastal atlas maps to the Geographic Information Systems 10 (GIS) format under the Coastal Impact Assistance Program. In the past, NOAA grant-funded 11 activities have included data gathering, mapping, ground-truthing, as necessary, and production of 12 completely updated resources for the Anchorage Bowl. 13

15 The State of Alaska's Coastal Impact Assistance Program grant period begins February 2003 and 16 ends in March 2005. This grant is a special, one-time grant for \$80,000 to update Anchorage's 17 Coastal Resource Atlas and provide GIS maps of Anchorage Bowl's current land use, roads and 18 utilities, slopes, streams/water bodies/tidal boundaries, soils, floodplains/wetlands, fish/wildlife 19 habitats, seismic areas and land cover. This atlas is an important resource for planners, 20 emergency management and other agencies. The atlas was last updated in 1983.

The majority of grant funds will be expended through contractual services, but it also will cover
some municipal personnel, travel, supply, and equipment costs. There are no matching
requirements.
