The attached resolution, if approved, will appropriate \$81,720 to cover additional costs associated with the 2002 Independent Audit. The KPMG contract states that the Internal Audit Department will "provide up to 700 hours of audit assistance per year." Due to lack of staffing, Internal Audit was not able to provide the required number of hours, therefore; in order to complete the Audit, an additional 220 hours of work was performed by KPMG. There were also three additional Federal major programs that had to be separately audited, additional client assistance relating to infrastructure and land capital assets, and additional hours for client assistance to the Utilities.
