A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THE SUM OF THIRTY NINE THOUSAND FIVE HUNDRED DOLLARS (\$39,500) FROM THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION & PUBLIC FACILITIES AND EIGHT HUNDRED TWENTY DOLLARS (\$820) AS A CONTRIBUTION FROM THE 2003 ANCHORAGE POLICE OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE STATE CATEGORICAL GRANTS FUND (231) ANCHORAGE POLICE DEPARTMENT, FOR THE IMPAIRED DRIVING ENFORCEMENT BLITZ PROGRAM.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of THIRTY NINE THOUSAND FIVE HUNDRED DOLLARS (\$39,500), is appropriated from the State of Alaska, Department of Transportation & Public Facilities to the State Categorical Grants Fund (231), Anchorage Police Department, for Impaired Driving Enforcement Blitz Program.

Section 2. That the sum of EIGHT HUNDRED TWENTY DOLLARS (\$820), is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2003 Anchorage Police Department Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

Subject: Appropriation from the State of Alaska, Department of Transportation & Public Facilities, of an Impaired Driving Enforcement Blitz Grant and local match required. (\$40,320)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities for a DUI .08 Impaired Driving Enforcement Blitz program. This grant will be used to support enforcement during the periods June 27, 2003 thru July 13, 2003.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of Impaired Driving violations within the Municipality of Anchorage. Through increased awareness and enforcement of Impaired Driving offenses, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$ 820, which has been budgeted in the 2003 Operating Budget. This grant will begin on June 27, 2003 and end on July 13, 2003.
