TWENTY SIX THOUSAND FOUR HUNDRED NINETY FIVE DOLLARS (\$26,495) FROM THE
STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES
MS/CVE AND FIVE HUNDRED THIRTY DOLLARS (\$530) AS A CONTRIBUTION FROM THE
2003 ANCHORAGE POLICE OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE
SERVICE AREA FUND (151), TO THE STATE CATEGORICAL GRANTS FUND (231)
ANCHORAGE POLICE DEPARTMENT, FOR THE COMMERCIAL VEHICLE INSPECTION
GRANT AGREEMENT.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of TWENTY SIX THOUSAND FOUR HUNDRED NINETY FIVE
DOLLARS (\$26,495) is appropriated from the State of Alaska, Department of Transportation and Public
Facilities MS/CVE to the State Categorical Grants Fund (231) for Commercial Vehicle Inspections.

Section 2. That the sum of FIVE HUNDRED THIRTY DOLLARS (\$530) is appropriated from the
Anchorage Metropolitan Police Service Area Fund (151), 2003 Anchorage Police Operating Budget as a
contribution to the State Categorical Grants Fund (231), Anchorage Police Department.

Section 3. This resolution shall take effect immediately upon passage and approval by the
Anchorage Municipal Assembly.

Subject: Appropriation from the State of Alaska, Department of Transportation and Public Facilities MS/CVE of a Commercial Vehicle Inspection Grant and local match required. (\$27,025)

The Municipality of Anchorage has entered into a standard agreement grant with the State of Alaska, Department of Transportation and Public Facilities MS/CVE under the Motor Carrier Safety Assistance Program. This grant will be used for commercial vehicle inspections within the Municipality in the amount of \$26,495.

The funding provided under this program will be used for the reimbursement of commercial vehicle inspections conducted in conjunction with commercial vehicle code enforcement. Through increased commercial vehicle safety inspections the residents of Anchorage will experience safer roads and reduced traffic accident injuries.

A condition of this grant is that the department makes a voluntary contribution to cover all indirect overhead charges from the Municipality. The total projected Municipal cost is \$530 which has been budgeted in the 2003 Anchorage Police Operating Budget. This grant began May 15, 2003 and will end on September 30, 2003.
