7 THE ANCHORAGE ASSEMBLY RESOLVES:

9 Section 1. That a sum of FOUR THOUSAND FIVE HUNDRED DOLLARS (\$4,500), received
10 from the State of Alaska, Department of Community and Economic Development, is hereby
11 appropriated to the State Categorical Grant Fund (231) for the continuing implementation of the
12 Anchorage Coastal Management Program. This amendment is in addition to the original grant
13 award of \$87,940 for state fiscal year 2003 that was approved by the Municipal Assembly on
14 December 17, 2002, per AR 2002-396.

Subject: AR 2003-181 Anchorage Coastal Management Program Grant Amendment
for FY 2003

On December 17, 2002, the Municipal Assembly approved AR 2002-396, appropriating \$87,940 in state grant funding for the Anchorage Coastal Management Program. The grant funds were for state fiscal year 2003, covering the period of July 1, 2002, through June 30, 2003. The Planning Department has been implementing the Anchorage Coastal Management Program for twenty-two years, and state grant funds pay part of the program's costs.

In preparing to close fiscal year 2003, the State of Alaska invited municipalities and coastal districts to apply for remaining, unspent grant funds. The Planning Department submitted an application, and the State of Alaska has approved an amendment to the Municipality's FY 2003 grant. The amendment awards an additional \$4,500 to the Municipality of Anchorage for the purpose of printing and reproducing recently updated wetlands maps for the Anchorage Bowl area.
