THE ANCHORAGE ASSEMBLY RESOLVES:

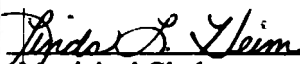
Section 1. That the sum of EIGHTY NINE DOLLARS (\$89), is appropriated as a grant from the

**Subject:** Appropriation from the Bureau of Justice Assistance, Office of Justice Programs, U.S. Department of Justice, of additional funds for a Bullet Proof Vest Partnership grant. (\$89)

The Municipality of Anchorage, Anchorage Police Department, has received additional grant funds from the Bureau of Justice Assistance, Office of Justice Programs, U.S. Department of Justice to offset the costs of supplying bullet proof vests to patrol officers in the amount of \$89.

The original grant award, approved June 25, 2002 AM 565-2002 AR 2002-204, was for the amount of \$2,360 with a required Municipal match of \$2,500 for a total grant program value of \$4,860. The additional funds will increase the total grant amount to \$4,949.

No additional Municipal matching funds are required. This grant began June 4, 2002 and will end September 30, 2006.
