1 A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING SEVENTEEN
2 THOUSAND NINE HUNDRED DOLLARS (\$17,900) FROM THE STATE OF ALASKA

4 SERVICES (ADES), TO THE STATE CATEGORICAL GRANTS FUND (231) TO SUPPORT THE
5 ANCHORAGE LOCAL EMERGENCY PLANNING COMMITTEE (LEPC) ACTIVITIES.

7 WHEREAS, the State of Alaska Department of Military and Veterans' Affairs, Division of
8 Emergency Services (ADES) has offered SEVENTEEN THOUSAND NINE HUNDRED
9 DOLLARS (\$17,900) to provide State Fiscal Year 2004 partial funding for the Anchorage LEPC
10 to pay salary/wages/benefits for Anchorage LEPC staff for July 1, 2003 thru June 30, 2004.

12 WHEREAS, the Administration and the Assembly have reviewed the grant offer by the State of
13 Alaska; and, therefore:

15 **THE ANCHORAGE ASSEMBLY HEREBY RESOLVES:**

17 Section 1. That a grant in the amount of Seventeen Thousand Nine Hundred Dollars (\$17,900) from the
18 State of Alaska Department of Military and Veterans' Affairs is appropriated to the State Categorical
19 Grant Fund 231, for use by the Office of Emergency Management within the Municipal Manager
20 Department to provide partial funding for the staff of the Anchorage LEPC.

22 Section 2. That this resolution shall be effective immediately upon passage by the Anchorage Municipal
23 Assembly.
