A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THE SUM OF SEVENTY TWO THOUSAND DOLLARS (\$72,000) FROM THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES, DIVISION OF STATEWIDE PLANNING HIGHWAY SAFETY OFFICE AND REAPPROPRIATING ONE THOUSAND FIVE HUNDRED TWENTY DOLLARS (\$1,520) OF CONTRIBUTIONS FROM THE 2002 SEAT BELT ENFORCEMENT GRANT, STATE CATEGORICAL GRANTS FUND (231) TO THE STATE CATEGORICAL GRANTS FUND (231) FOR THE SEAT BELT ENFORCEMENT PROGRAM.


THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of SEVENTY TWO THOUSAND DOLLARS (\$72,000) is appropriated as a grant from the State of Alaska, Department of Transportation and Public Facilities, Division of Statewide Planning Highway Safety Office to the State Categorical Grants Fund (231) for Seat Belt Enforcement.


Section 2. That the sum of ONE THOUSAND FIVE HUNDRED TWENTY DOLLARS (\$1,520) is reappropriated from the State Categorical Grants Fund (231), 2002 Seat Belt Enforcement Grant contributions to the State Categorical Grants Fund (231), 2003 Seat Belt Enforcement Grant.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

Subject: Appropriation from the State of Alaska, Department of Transportation and Public Facilities, Division of Statewide Planning Highway Safety Office, of a Seat Belt Enforcement Grant. (72,000)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation and Public Safety, Division of Statewide Planning Highway Safety Office for a grant to support increased seat belt use in the amount of \$72,000.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of seat belt use within the Municipality of Anchorage. Through increased awareness and enforcement, the residents of Anchorage will be encouraged to increase seat belt usage to reduce traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected municipal cost is \$1,520, which was overfunded in the 2002 Seat Belt Enforcement Grant. This grant will begin August 25, 2003 and will end on September 7, 2003.
