The Department of Health and Human Services has received a grant award from the Alaska Department of Health and Social Services in the amount of Nine Hundred Sixty Thousand Eight Hundred Fourteen Dollars (\$960,814). The grant funds a portion of public health nursing functions. The period of the grant is from July 1, 2003 to June 30, 2004. Expenditures are approved from July 1, 2003.

The State of Alaska has granted funds to the Municipality of Anchorage for "core" public health services since 1966, when the Anchorage community voted for public health powers. This grant was established to fund those public health services provided elsewhere by the state government.

Under the terms of the grant, the Department of Health and Human Services will provide:

- general public health nursing services
- community education (i.e., maternal and child health issues, communicable disease issues)
- immunizations
- TB control services
- epidemiological investigations of communicable diseases
- reproductive health services
- screening and testing for communicable diseases
- home and office visits to high risk pregnant women, infants and young children
- data collection and reporting for services rendered
- maintenance of financial records which are readily accessible for state or federal review
