COMPLETE THE AFFIRMATIVE ACTION PLAN

Federal regulations require that a Municipality having more than \$50,000 in annual contracts with the Federal government and employing more than 50 employees is required to prepare an annual written Affirmative Action Plan addressing minorities, women, covered veterans, and persons with disabilities. Last year, it was discovered that the Municipality of Anchorage's Plan had not been updated since 1998; therefore, the Assembly appropriated \$20,000 for this purpose. At that time, a contract was let to update the Plan using current census data because the 2000 census data was not available. At the end of last year, \$9,600 of this appropriation was not encumbered, and lapsed into fund balance before the work was completed. One of the goals of the Office of Equal Opportunity is to bring the Municipality's Plan to fruition by extending the contract to complete the Plan using the current census data, and amend the data format making the document more user friendly. Additionally, a plan for increasing diversity will be developed in-house, with input from the community at-large.

The attached resolution, if approved, will re-appropriate \$9,600 to the Employee Relations Department's Office of Equal Opportunity to complete the Plan. The funding information follows:
