20 THE ANCHORAGE ASSEMBLY RESOLVES:

21 Section 1. That a sum not to exceed TEN THOUSAND (\$10,000) DOLLARS is  
22 hereby appropriated from a grant awarded by the State of Alaska, Department of Education,  
23 Division of State Libraries, to the State Categorical Grant Fund (231), for the Spanish, ESL  
24 and Literacy Collection.


25 Section 2. That a sum not to exceed ONE HUNDRED NINETY (\$190) DOLLARS  
26 is hereby appropriated as a contribution from the 2003 Library Operating Budget within the  
27 Areawide General Fund (101), to the State Categorical Grant Fund (231) Cultural and  
28 Recreational Services, for the Spanish, ESL and Literacy Collection.

29 Section 3. That this resolution shall take effect immediately upon passage and  
30 approval.

**Subject:** Appropriation of a State Categorical Grant from the State of Alaska for the **SPANISH, ESL, AND LITERACY COLLECTION GRANT (\$10,000)** and operating budget (\$190) contribution to the Spanish, ESL, and Literacy Collection grant for the Library.

Notification has been received that the Anchorage Municipal Libraries have been awarded a grant by the State of Alaska, Department of Education, Division of Libraries, to the State Categorical Grant Fund (231) Cultural and Recreational Services Department, for the Spanish, ESL, and Literacy Collection grant (\$10,000). The Municipal contribution required (\$190) for the Spanish, ESL, and Literacy Collection grant will be used for internal government charges and is currently budgeted in the 2003 Library operating budget, within the Areawide General Fund (101). These grant funds and contributed match cover the grant period of July 1, 2003 through June 30, 2004.

The Spanish, ESL, and Literacy Collection grant will develop a basic collection of Spanish language materials and expand the ESL and New Reader literacy collection to facilitate learning to read and speak English.
