Local Law Enforcement Block Grants, authorized by the Omnibus Consolidated and Emergency Supplemental Appropriations Act, 1999 Public Law 105-277, provide local governments with funds to underwrite projects to reduce crime and improve public safety. The Municipality of Anchorage has been awarded a grant in the amount of \$286,363 with a required local match of \$31,818 for a total program budget of \$318,181. These amounts are requested to be appropriated to the Federal Categorical Grants Fund (241) for use by the Anchorage Police Department. The term of this grant is 24 months from the date drawn by the Municipality.

The Grant Advisory Board met on September 9, 2003 and recommended the use of funding as follows:
