1 A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY CALLING A SPECIAL ELECTION IN
2 AND FOR THE MUNICIPALITY OF ANCHORAGE ON NOVEMBER 25, 2003, FOR THE PURPOSE OF
3 VOTING ON A BALLOT PROPOSITION AUTHORIZING FIRE HYDRANT MAINTENANCE AND THE
4 INFRASTRUCTURE ON AN AREAWIDE BASIS.

8 WHEREAS, the public health, safety, and welfare are affected by fire, earthquakes, floods, and other
9 catastrophes, natural and manmade, which cause loss of life, property, and livelihoods, impacting the entire
10 community; and

12 WHEREAS, through existing fire service areas, the Anchorage Fire Department, the Chugiak Volunteer
13 Fire Department, and the Girdwood Volunteer Fire Department play primary roles in fire suppression and disaster
14 response within their respective jurisdictions; and

16 WHEREAS, fire and disaster, whether natural or manmade, do not respect political or governmental
17 boundaries and instead pose a continuing threat to all of the residents of Anchorage; and

19 WHEREAS, the cost of operating and maintaining an integrated system of fire hydrants in Anchorage is
20 largely borne by the existing Anchorage Fire Service Area even though such activities benefit all of the citizens of
21 Anchorage regardless of where they reside.

23 NOW THEREFORE, THE Anchorage Assembly resolves:

25 Section 1. A special election in and for the Municipality of Anchorage is called to be held on
26 November 25, 2003, for the purpose of voting on a ballot proposition authorizing levy of a special tax to provide
27 fire hydrant maintenance and infrastructure on an areawide basis.

29 Section 2. This resolution shall become effective immediately upon its passage and approval.
