WHEREAS, the Maintenance and Operations Department is authorized to expend Rabbit Creek LRSA funds appropriated by the Anchorage Assembly; and

WHEREAS, Fourteen Thousand Dollars (\$14,000) are available in Rabbit Creek LRSA Fund Balance (Fund 145); and

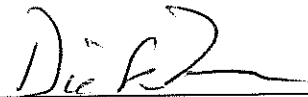
WHEREAS, said funding is needed by Rabbit Creek LRSA to provide BY2003 year round road maintenance services.

THE ANCHORAGE ASSEMBLY RESOLVES:

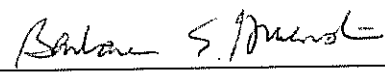

SUBJECT: Resolution Appropriating Fourteen Thousand Dollars (\$14,000) from Rabbit Creek Limited Road Service Area (LRSA) Fund Balance (Fund 145) to Rabbit Creek LRSA BY2003 General Operating Budget (Fund 145) for Year Round Road Maintenance Services.

The attached Resolution appropriates \$14,000 of fund balance from Rabbit Creek LRSA (Fund 145) to Rabbit Creek LRSA BY2003 General Operating Budget (Fund 145) for year round road maintenance services.
