A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THREE THOUSAND DOLLARS (\$3,000) FROM TOTEM LIMITED ROAD SERVICE AREA (LRSA) FUND BALANCE (FUND 124) TO TOTEM LRSA BY2003 OPERATING BUDGET (FUND 124) FOR YEAR ROUND ROAD MAINTENANCE SERVICES.

WHEREAS, the Maintenance and Operations Department is authorized to expend Totem LRSA funds appropriated by the Anchorage Municipal Assembly; and

WHEREAS, Three Thousand Dollars (\$3,000) are available in Totem LRSA Fund Balance (Fund 124); and

WHEREAS, said funding is needed by Totem LRSA to provide BY2003 year round road maintenance services.

THE ANCHORAGE MUNICIPAL ASSEMBLY RESOLVES:

**Section 1.** That Three Thousand Dollars (\$3,000) from Totem LRSA Fund Balance (Fund 124) is hereby appropriated to Totem LRSA BY2003 Operating Budget (Fund 124).
