A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING ONE HUNDRED THIRTY NINE THOUSAND THREE HUNDRED SEVENTY TWO DOLLARS (\$139,372) OF UNAPPROPRIATED REVENUE AND REAPPROPRIATING ONE HUNDRED SIXTY THREE THOUSAND SIX HUNDRED TWENTY EIGHT DOLLARS (\$163,628) FROM THE AREAWIDE GENERAL CAPITAL IMPROVEMENT FUND (401), AS A CONTRIBUTION TO THE AREAWIDE GENERAL FUND (101) FOR THE PURPOSE OF REIMBURSEMENT TO SMG OF ALASKA FOR THE 2002 OPERATING DEFICIT.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That One Hundred Thirty Nine Thousand Three Hundred Seventy Two Dollars (\$139,372) is appropriated from revenues in the Areawide General Capital Improvement Fund (401) as a contribution to the Areawide General Fund (101) for the purpose of reimbursement to SMG of Alaska for their FY 2002 operating deficit of the George M. Sullivan Arena.

Section 2. That One Hundred Sixty Three Thousand Six Hundred Twenty Eight Dollars (\$163,628) is reappropriated from the Areawide General Capital Improvement Fund (401) as a contribution to the Areawide General Fund (101) for the purpose of reimbursement to SMG of Alaska for their FY 2002 operating deficit of the George M. OPERATING DEFICIT.

SMG of Alaska, Inc., manages and operates the Sullivan Arena in accordance with a professional services contract dated June 16, 2001. This contract provides for reimbursement to the Contractor in the event of an operating deficit. Due to numerous factors beyond the control of SMG, a deficit of \$303,000 exists for 2002. Contributing factors to lower than expected revenues include decreases in attendance at UAA Seawolf and Anchorage Aces hockey games, depressed tourism industry, and residual effects from September 11, 2001.

 The contract with SMG provides for set aside of 5% of Gross Revenues monthly into a Reserve Account within the Areawide Capital Improvement Fund. The Reserve Account is intended to be used for major repairs, upgrades, emergencies, and reimbursement to the Contractor for any operations deficit. The available balance of prior appropriations of reserves for capital improvements totals \$163,628. This amount will be combined with funds from the unappropriated Sullivan Reserve Account in the amount of \$139,372 for a total amount of \$303,000 to cure their FY 2002 operating deficit.

SMG is currently pursuing other forms of high revenue-producing entertainment events to mitigate a projected 2003 shortfall.
