**A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY SUPPORTING THE
EXTENSION OF THE EAST ANCHORAGE WEED AND SEED PROGRAM AND THE
EXPANSION INTO NEW AREAS OF THE RUSSIAN JACK AREA**

WHEREAS, Operation Weed and Seed is a Federally sponsored effort to make
neighborhoods safe; and

WHEREAS, Operation Weed and Seed is a strategy to reduce and prevent crime with the
goal of "weeding out crime" and "seeding" communities with positive resources; and

WHEREAS, the initial East Anchorage Weed and Seed Program has been very successful
in uniting the community to fulfill its goals of reducing crime and bringing together many positive
programs for the community; and

WHEREAS, continued and expanded recognition as a Weed and Seed location opens the
prospects for other Federal funding opportunities; and

WHEREAS, program elements will include law enforcement, community policing,
prevention/intervention treatment and neighborhood revitalization, and the Program will be housed
and managed within the targeted neighborhoods; and


WHEREAS, the basic process has begun with a local steering committee completing the
required application, to include representatives from the Mayor's Office, the Assembly, churches,
social service agencies, businesses, schools, and others.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves:


Section 1: That the Assembly supports the East Anchorage Weed and Seed renewal and
expansion application.

Section 2: That the Administration is strongly encouraged to participate and support the
East Anchorage Weed and Seed application for renewal and expansion.
