A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THE SUM OF SEVENTY ONE THOUSAND FIVE HUNDRED DOLLARS (\$71,500) FROM THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION & PUBLIC FACILITIES AND REAPPROPRIATING NINE HUNDRED FIFTY THREE DOLLARS (\$953) OF CONTRIBUTIONS FROM THE 2002 IMPAIRED DRIVING BLITZ GRANT, STATE CATEGORICAL GRANTS FUND (231) AND FIVE HUNDRED FIFTY SEVEN DOLLARS (\$557) AS A CONTRIBUTION FROM THE 2003 ANCHORAGE POLICE OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE STATE CATEGORICAL GRANTS FUND (231) ANCHORAGE POLICE DEPARTMENT, FOR THE IMPAIRED DRIVING ENFORCEMENT BLITZ PROGRAM.

THE ANCHORAGE ASSEMBLY RESOLVES

Section 1. That the sum of SEVENTY ONE THOUSAND FIVE HUNDRED DOLLARS (\$71,500), is appropriated from the State of Alaska, Department of Transportation & Public Facilities to the State Categorical Grants Fund (231), Anchorage Police Department, for Impaired Driving Enforcement Blitz Program.

Section 2. That the sum of NINE HUNDRED FIFTY THREE DOLLARS (\$953) is reappropriated from the State Categorical Grants Fund (231), 2002 Impaired Driving Blitz Grant contributions and FIVE HUNDRED FIFTY SEVEN DOLLARS (\$557), is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2003 Anchorage Police Department Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department, for Impaired Driving Enforcement Blitz Program.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

**Subject:** Appropriation from the State of Alaska, Department of Transportation & Public Facilities, of an Impaired Driving Enforcement Blitz Grant and local match required. (\$73,010)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities for a DUI .08 Impaired Driving Enforcement Blitz program. This grant will be used to support various blitz period enforcement during the periods October 31, 2003 thru September 30, 2004.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of Impaired Driving violations within the Municipality of Anchorage. Through increased awareness and enforcement of Impaired Driving offenses, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$ 1,510, of which \$953 was overfunded in the 2002 Impaired Driving Blitz Program Grant and \$557 which has been budgeted in the 2003 Operating Budget. This grant will begin on October 31, 2003 and end on September 30, 2004.
