A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THE SUM OF THIRTY EIGHT THOUSAND EIGHT HUNDRED THIRTY FIVE DOLLARS (\$38,835) FROM THE STATE OF ALASKA, DEPARTMENT OF PUBLIC SAFETY, DIVISION OF ALASKA STATE TROOPERS AND REAPPROPRIATING TEN THOUSAND THREE HUNDRED THIRTEEN DOLLARS (\$10,313) OF CONTRIBUTIONS FROM THE 2001 METHAMPHETAMINE ENFORCEMENT GRANT, STATE CATEGORICAL GRANTS FUND (231) AND REAPPROPRIATING THREE THOUSAND FOUR HUNDRED FIFTY TWO DOLLARS (\$3,452) OF CONTRIBUTIONS FROM THE 2002 PRESCRIPTION DRUG FRAUD ENFORCEMENT GRANT, STATE CATEGORICAL GRANTS FUND (231) TO THE STATE CATEGORICAL GRANTS FUND (231) FOR A 2003 PRESCRIPTION FRAUD ENFORCEMENT GRANT.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of THIRTY EIGHT THOUSAND EIGHT HUNDRED THIRTY FIVE DOLLARS (\$38,835), is appropriated from the State of Alaska, Department of Public Safety, Division of Alaska State Troopers, to the State Categorical Grants Fund (231) for 2003 Prescription Drug Fraud Enforcement.

Section 2. That the sum of TEN THOUSAND THREE HUNDRED THIRTEEN DOLLARS (\$10,313) is reappropriated from the State Categorical Grants Fund (231), 2001 Methamphetamine Enforcement Grant contributions to the State Categorical Grants Fund (231), 2003 Prescription Drug Fraud Enforcement.

Section 3. That the sum of THREE THOUSAND FOUR HUNDRED FIFTY TWO DOLLARS (\$3,452) is reappropriated from the State Categorical Grants Fund (231), 2002 Prescription Drug Fraud Enforcement Grant contributions to the State Categorical Grants Fund (231), 2003 Prescription Drug Fraud Enforcement.

Section 4. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

**Subject:** Appropriation from the State of Alaska, Department of Public Safety, Division of Alaska State Troopers, of a Prescription Drug Fraud Enforcement Grant (\$52,600).

The Municipality of Anchorage has received from the State of Alaska, Department of Public Safety, Division of Alaska State Troopers, a Prescription Drug Fraud Enforcement Grant in the amount of \$38,835.

This grant, as governed by the Anti-Drug Abuse Act of 1988, Public Law 100-690, Title VI, Subtitle C, will be used by the Anchorage Police Department to identify leads, investigate, and make arrests associated with illegal activity involving prescription drug fraud enforcement.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$13,765 of which \$10,313 was overfunded in the 2001 Methamphetamine Enforcement grant and \$3,452 was overfunded in the 2002 Prescription Drug Enforcement grant. This grant began on October 1, 2003 and will end on September 30, 2004.
